Planned Giving Workshop

Learn how to maximize the benefit of your charitable gifts.

Hal Reed, a UU from Auburn, AL, and the Director of Planned Giving for Auburn University, will present a workshop on Saturday afternoon, May 23, as part of the members and donors weekend. "Will, Trust and Taxes: How you can reap big benefits through planned giving" is a great chance for attendees to obtain up-to-date information from a professional in this field.

A lawyer by trade, Hal spent many years in the banking field before moving to Auburn in 1997. In offering to present this workshop, he said, "Most of us are familiar with outright cash gifts to charitable organizations. But few know much about 'planned gifts', such as charitable annuities, trusts and bequests. This presentation will focus on benefits such as major income tax deductions, lifetime income opportunities and estate tax avoidance through planned giving."

The Alabama Tour

Visiting the Cradle of the Modern Civil Rights Movement

Mountain staff were on the road again in February! Larry Wheeler and Quartet members Jane Warth, Tom Warth, Shelley Denham and Ian Denham were warmly welcomed by all the Alabama UU Congregations visited on the tour. We especially thank the folks who coordinated each event: Rev. Diane Jordon (Auburn), Rev. Elena Rigg (Montgomery), Deb Crocker (Tuscaloosa), Mike Taylor (Birmingham) and Mary Ann Ely and Rev. Doak Mansfield (Huntsville). We also appreciate the Chattanooga congregation and coordinator, Jim MacCoubrey, who were supportive of our need to cancel their concert at the last minute, as it allowed us to return home in time to be with Buddy Brown and the rest of the staff for the memorial services for Buddy's wife, Marge (see article pg. 4).

It is always a joy to connect with UU congregations, but this tour took on unexpected meaning for us as we visited several sites of significance to the Civil Rights movement. We spent one morning at the Southern Poverty Law Center, and were inspired by the work this organization is doing in the areas of justice and education. Enthusiastic staff gave us a tour of the center and we came away with multiple emotions: gratitude...for the work that the SPLC is doing, despite real physical danger and huge obstacles, anger and frustration...that the intense security measures at the center are necessary, and that more people don't know about and support the SPLC.

and motivation... to find meaningful ways to collaborate appropriately in support of our mutual commitment to justice work.

The second site we visited was the Dexter Avenue King Memorial Baptist Church, right down the street from the SPLC. Dr. Martin Luther King, Jr. filled the pulpit there for six years - his last congregational ministry before he entered into full time Civil Rights activism. Although there was no tour scheduled that day, church staff welcomed us warmly. We were shown a video of the impact the Dexter Avenue congregation has had throughout the years and there was a palpable presence of people like Dr. King, Rosa Parks and Ralph Abernathy within those historic walls. We spent some time alone in the sanctuary and were moved by a sense of urgency: we have come a long way from the 50s and 60s—but we have a long way to go before the inherent worth and dignity of all people is recognized by society as a whole.

On our way to Selma, we tracked the route that brave participants took to Montgomery in that famous march...and we read aloud from history books the dramatic involvement of Unitarian Universalists such as Rev. James Reeb and Clark Olsen (our friend and neighbor in Asheville, NC).

Our Alabama tour became a personal and professional pilgrimage, and we came home changed and inspired. This experience served as a resounding affirmation that The Mountain's vision, mission and values are clearly needed in the world...and we have only just begun to work for positive change!

As I am writing this column today, the 18th of March, the gas company is here installing service to Cabins 18 and 19 in the pouring rain. New ramps and bunk beds were finished last week, flooring was installed yesterday and the plumbing will be done tomorrow morning – all in time to welcome our first occupants Thursday evening, participants in the African Drum & Dance weekend. The other cabins are being worked on too, as Cabins 14 through 19 must be ready for occupancy by April 3rd. The cabin upgrades are an exciting project – and we are meeting our deadlines.

In the last issue of *The Mountain Matters*, I said I'd like to put a list of staff names and responsibilities in this issue. Due to space limitations (since this is the election issue), the staff feature will not appear this month but will be in our May edition. In the meantime, we have welcomed two new staff members this past month: Wendy Capps, a young adult from Rabun Gap has joined our housekeeping staff; Jameson Di Marino, originally from New Mexico, educated

at the Culinary Institute of Vienna, with experiences at the Pentagon and Princess Cruise Lines, has joined our food service staff. In addition, we have hired Brian Horvitz as our second REFLIEL mentor, beginning in June. Brian has been a CIT mentor the last two summers, received his M.S. Ed from the University of Pennsylvania and is currently working in Washington, D.C. in computer research. This appointment is a real testament to the success of the REFLIEL program as we expect to have eight students joining us in August.

A Program for Mind, Body and Spirit!

UU Week 1998, June 3-7

The Mountain offers again this year a four-day program for Unitarian Universalists and other religious liberals. Explore the life of the mind - through stimulating workshops addressing contemporary issues, the body - with outdoor activities and trips around the Highlands area, and the spirit - spending an evening with The Mountain Quartet.

Dr. John Cairns, preeminent authority on ecological restoration, and a UU from Blacksburg, VA, will offer energizing new ways of thinking about environmental issues. John, loves to speak to groups of all ages, trying out new ideas and learning from his class participants in return. His workshop, *Sustaining Our Legacy*, examines what it could mean to truly embrace the 7th Principle of Unitarian Universalism. Topics for discussion will include: "Individual Rights vs. The Rights of Future Generations"; "Targeted Compassion vs. General Compassion: The Influence Of Bambi And How We View Natural Systems"; "Respecting the Interdependent Web: Can we make our environment more hospitable?"

John Jeffrey Stein, a UU from Nashville, TN, will lead *Searching for Character*, a workshop exploring recent national concerns about the character, values and ethics of our

leaders and assumptions about the defining attributes of character. Jeff uses clips from classic movies as a stimulus for exploring idealism, individualism, integrity and the ethics of character. Currently professor of screenwriting and motion picture production at Tennessee State University and the Waskins Institute Film School, Jeff is also the author of *Gentlemen of Decision*, a political thriller.

Music is a universal tool for communication: it is the language of the spirit that knows no cultural, religious or social barriers. Members of The Mountain Quartet will share an evening of musical reflection based in their commitment to putting their UU values into action. We can all be change agents, whether in our interactions with family and friends, in specific social justice activities or in the study of political issues. The Quartet shares a selection of music to offer inspiration, joy and strength in our struggle to translate ideals into reality.

Enjoy The Mountain in one of the best of seasons! We never know what will be blooming the first week of June - early spring, late spring or summer wildflowers - but you can be sure Mother Nature will be putting on a splendid, delicate show. Depending on the weather and the group's wishes, additional activities may include nature hikes, fun and games on the lake, group-building challenges on the Initiatives Course, an excursion to the Botanical Gardens and the world's third largest tulip poplar, or an afternoon of simply enjoying the spectacular views. Leave a Legacy for The Mountain

The Mountain Endowment Fund, Inc., was established in early 1997 to "enhance the current and long-term financial viability of The Mountain Retreat & Learning Center." The Endowment is a permanent fund: its purpose is to preserve and protect the irreplaceable resources of The Mountain, now and for future generations.

As of April 1998, the Endowment Board has documentation that twenty one people have made provisions for the Mountain Endowment through their estate. A broad range of beneficiary vehicles are available, including wills or trusts, insurance policies, or IRA-qualified retirement plans. Many of these gifts have been matched by an anonymous donor. The holdings of the Endowment Fund are currently \$143,867. Our deepest thanks go to these donors who are making The Mountain a part of their personal legacy.

The interest paid is equal to the current Five-Year Treasury Note rate plus an additional half percent for Notes up to \$3,000 or an additional one percent for those \$6,000 and above. Notes are issued in increments of \$1,000 for periods of sixty months. 
Marge Brown 1940-1998

An Appreciated Gift

Avoid capital gains taxes and benefit The Mountain.

As this issue goes to press, the stock market continues to hit new highs. But, as June 30, 1998 draws near, so does the expiration date of the tax regulation which allows holders of appreciated stocks to contribute their investment to a non-profit organization at full market value without having to pay taxes on capital gains. While the regulation may once again be extended, there are no guarantees. Now is a great time to take advantage of the tax code and donate appreciated stocks to The Mountain. Here's an example of how it works:

Original purchase price: \$10 per share x 20 shares = \$200 initial investment

Today's price: \$100 per share x 40 shares (split 1:1) = \$4,000 current value

The capital gain which must be claimed upon the sale of this example investment is \$3,800. But, if the stock is donated to a nonprofit like The Mountain, the investor takes a tax deduction on the entire \$4,000. Think about it! Report of the Nominating Committee

To: All current Members and Donors of The Mountain Retreat & Learning Center, Inc.

The business of The Mountain Retreat & Learning Center, Inc. is managed under the direction of the Board of Trustees. The Board has the responsibility for setting the long term direction of The Mountain, articulating the organization's values, vision and mission, and establishing broad management policies. Members of The Board of Trustees are not involved in the day-to-day operations of The Mountain.

The Board is currently composed of nine members, six elected and three appointed. Four of the elected trustees will continue to serve for the year 1998-99. They are: Gretchen Bremer-Hoskin (Florida), John Lantz (Georgia), President-Elect John Bohstedt (Tennessee) and Melanie Sullivan (Tennessee). In line with The Mountain's Bylaws, two Trustees must be elected this year, for three year terms each, bringing

to six the total number of elected trustees for 1998-99.

Therefore, the Nominating Committee submits two candidates for this year's single slate: John Bohstedt (Tennessee) and Jeri Moulder (California). We believe these two people bring the needed skills, energy and commitment to the work of the Board of Trustees. Your supportive vote for these two nominees is recommended.

In addition, the Board has appointed Ed Mangiafico (California) to a three year term beginning in May, 1998. Ed is a long time Unitarian Universalist, who has served on many for-profit and not-for-profit boards, nationwide. He is past Chairman and CEO of Gruen Marketing Corporation and past Chairman of the May Company of California and Nevada. We are very fortunate to have someone of Ed's background, experiences and commitment to Unitarian Universalism agree to serve on the board of The Mountain.

Other appointed Trustees who have agreed to continue to serve for the coming year are Financial Advisor to the Board, Jeannette Manning (North Carolina) and Recording Secretary, Claire Keane (Georgia).
